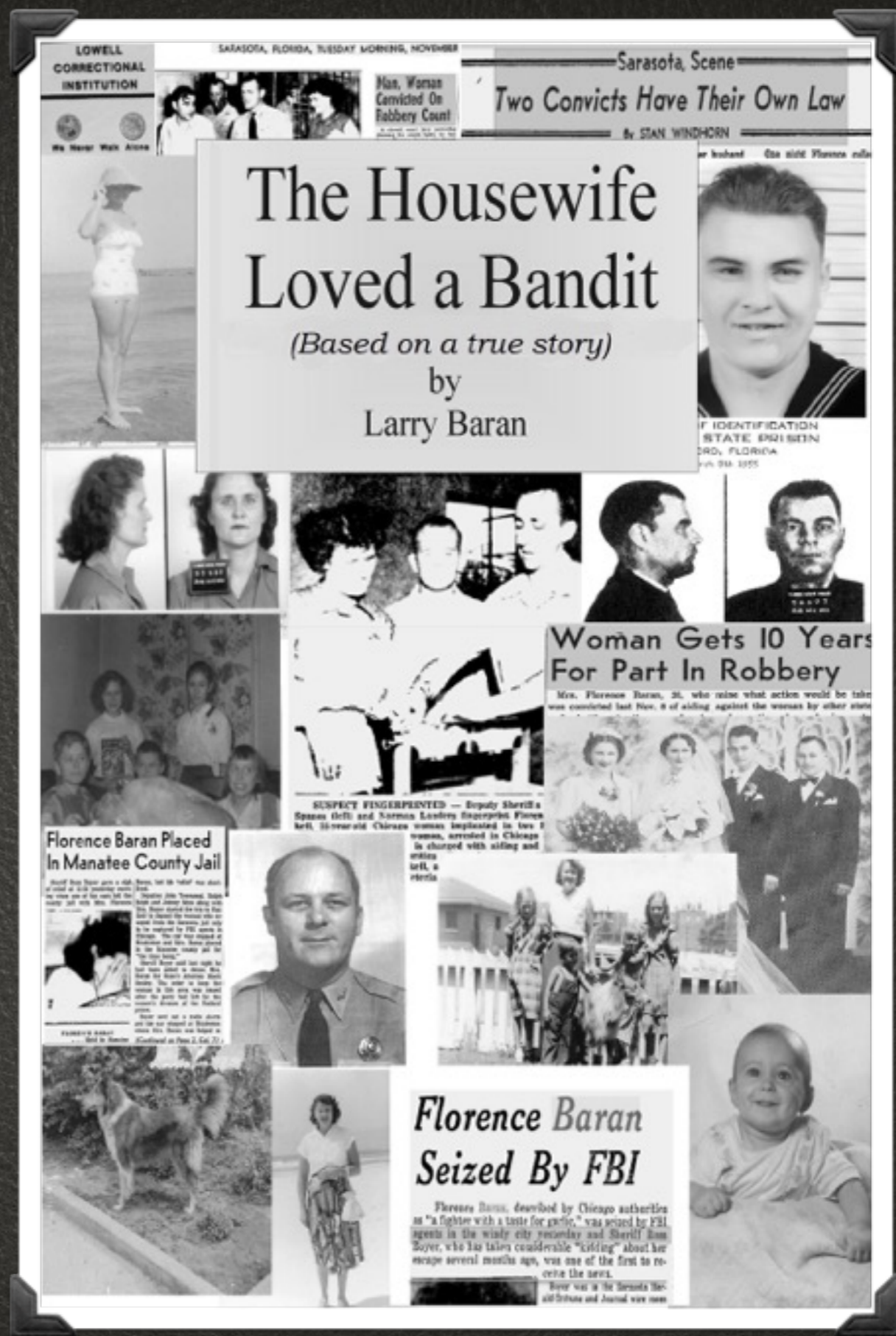

LOGLINE

Based on a true story, a frustrated 1950s housewife meets a smooth-talking ex-con then leaves her husband and six kids for an adventurous, cross-country crime spree as the getaway driver while he plays the gun-toting bandit.

SETTING

We start with a typical post-World War Two family at their Hyde Park, Chicago home with a spacious white picket fenced-in yard, a collie dog named Lassie, a hard working husband and mother raising six children. The crime spree begins on Route 66 to the west coast and ends in Miami, Florida. Action also unfolds in Sarasota, Florida where, after conviction, the Housewife brazenly breaks out of jail.

MOOD

This story captures the era's nostalgia and post-war angst with a mix of music, drama and comedy, It navigates a rollercoaster of emotions, blending moments of middle class family life, love and betrayal with unexpected bursts of humor. This is enhanced by the black-and-white opening scenes switching to full color as the story progresses. The story world is bright and funny, dark and dangerous.

SYNOPSIS

It's a hot afternoon on July 26, 1954, at our home in Hyde Park, Chicago. I was 4 years old, helping my mom, FLO BARAN (35), load bags of dirty laundry into the car. Suddenly, FBI and Chicago police appear and arrest her. Friends and family watch as she puts up a big fight. It takes five men to subdue her, slip on the handcuffs and force her into an unmarked car. Nobody knew why this was happening except for law enforcement.

Flashback 11 months to August 1953.

Mom, dad and six kids are living a typical family life until mom meets the bandit, BILL GASKELL (26), a wisecracking, tough guy parolee, at a local bar. Flo and husband, WALLY BARAN (42), have had a tumultuous relationship for years. Tender family moments with the kids happen in between frequent domestic squabbles. For Flo, the embarrassment of being yelled at and belittled by Wally coupled with the endless, thankless tasks of being a full time mother to six made it feel like the walls were slowly closing in on her. She feels as though her own life is passing her by until her affair with Bill pulls her away and he offers her the chance to escape it all. Wally catches on to Flo and Bill. Tensions escalate. Flo makes the decision to leave her family and join Bill on a cross-country crime spree.

Their cross-country crime spree begins on Route 66 and lasts for seven months, They get married in Las Vegas, commit over 25 armed robberies and successfully evade capture. Their relationship begins to sour and Flo decides to leave him. In June, 1954, she turns him in to Miami authorities, takes his car and returns to Chicago. Bill returns the favor leading to Flo's dramatic arrest at her home on July 26, 1954.

Sarasota County Sheriff, ROSS BOYER, flies to Chicago to escort Flo back to Florida to stand trial with Bill. Flo is a very uncooperative prisoner known for playing her harmonica, screaming at deputies, breaking plumbing fixtures, tearing up her cell and ripping off her clothes. Fellow prisoners call her a "noisy wench" among other things.

In November, 1954, Flo and Bill are convicted of armed robbery. He gets fifteen years and is sent to Tallahassee to stand trial for crimes there. Flo remains in Sarasota pending the outcome of Bill's trial. On January 19, 1955, Flo is sentenced to ten years in prison. Four days later, she breaks out of jail in the middle of the night. She hitchhikes to Tampa and has her sister STELLA wire money for bus fare back to Chicago. On April 26th, FBI arrests FLO in another violent encounter. Back in Florida, she agrees to testify against the JANITOR who helped her escape.

Flo completes half of her ten year sentence at Lowell Correctional Institution for women as a model prisoner. She completes her chores, makes dolls to send home and earns her High School Diploma. In May, 1959, Parole is granted. She returns home to her family in Chicago, a changed woman.

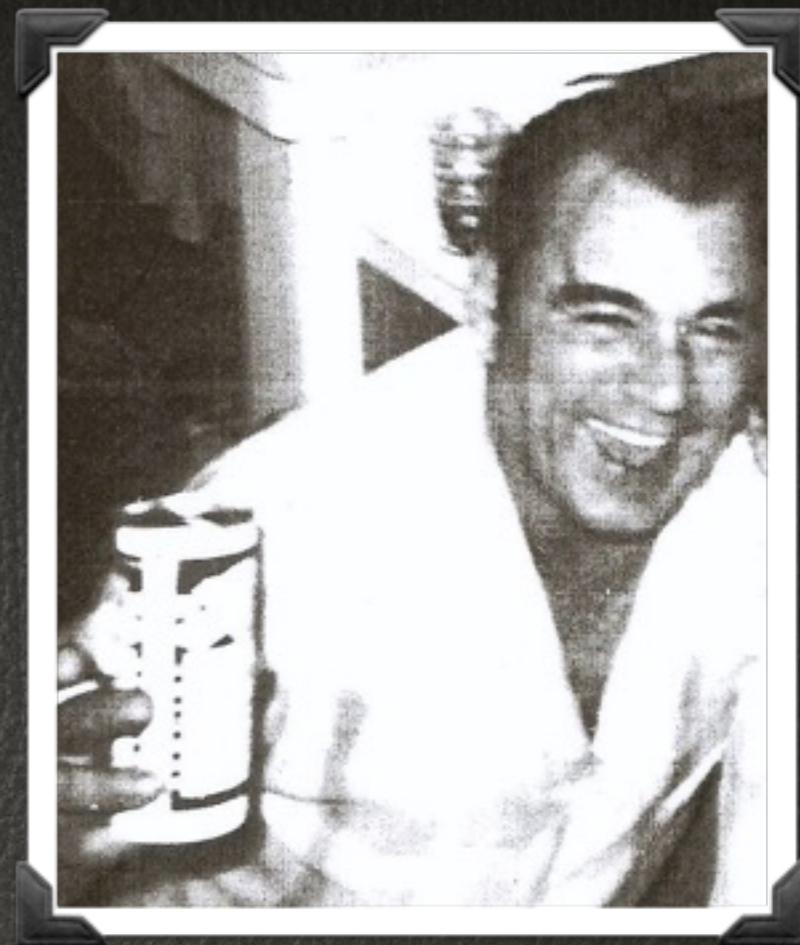
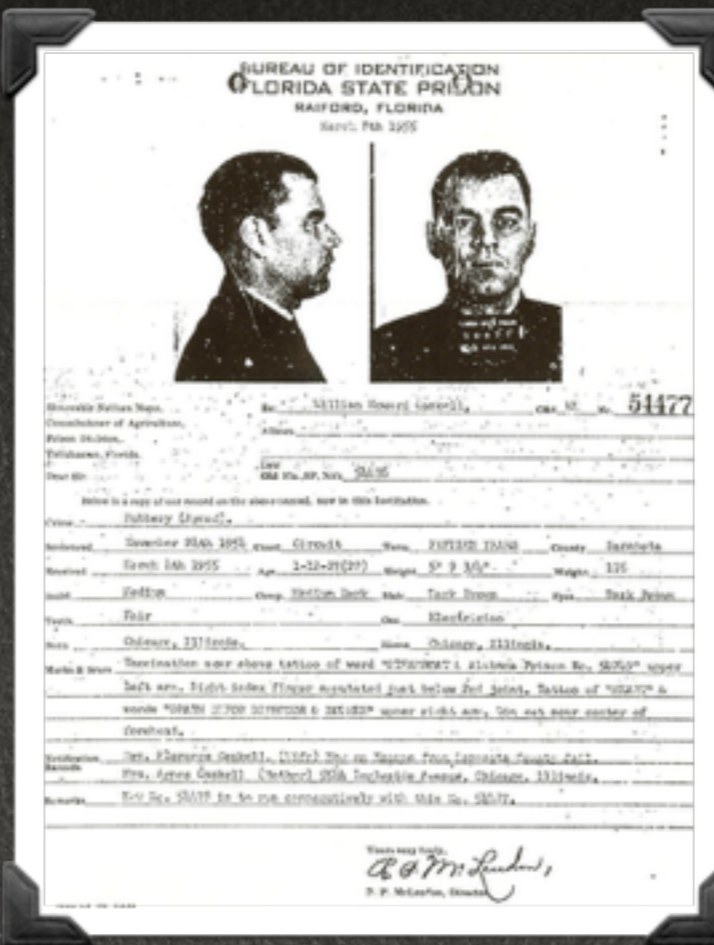

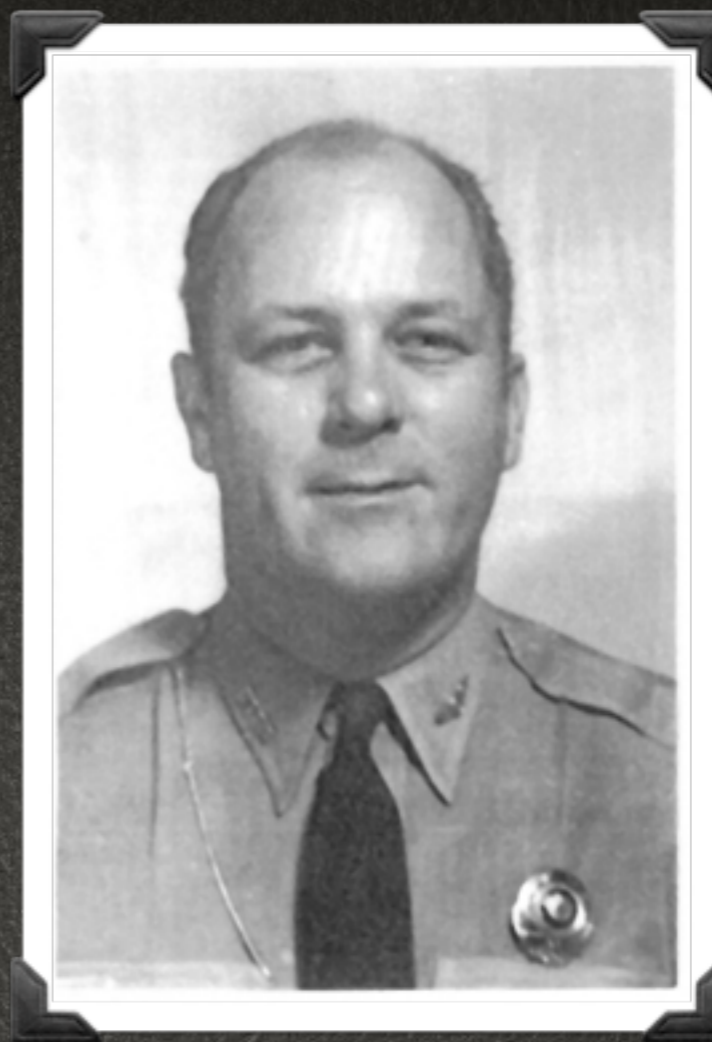

In the movie and in real life, thankfully, Flo and Bill never shot a gun. Bill's intimidating tough guy persona persuaded victims to give up their cash without a fight. Ultimately, the gun was just for show. Although the films listed below lack the family element, they share themes of crime, rebellion, and complex character dynamics, making them similar in spirit to "THE HOUSEWIFE LOVED A BANDIT."

Bonnie and Clyde (1967): Set in the 1930s, this classic film tells the story of the infamous criminal couple, Bonnie Parker and Clyde Barrow, who go on a crime spree during the Great Depression. It captures the excitement and danger of a life of crime. Gaskell mentions Clyde insisting they shared a similar reason and M.O. for their crimes.

Thelma & Louise (1991): This film follows two contemporary women who embark on a crime spree after a series of unfortunate events. It explores themes of friendship, freedom, and rebellion.
